EVALUATION CRITERIA

1. Functionality

This method of evaluation will be used as a pre-requisite for all the service providers/suppliers to qualify for the second stage of evaluation where **PRICE** and **HDI** and / or other **RDP** goals will be used.



A minimum threshold of **30 percent** must at least be achieved by service providers/suppliers for them to proceed to the second stage of evaluation. **See tender document for more details.**

2. PRICE, HDI/RDP GOALS

All the service providers/suppliers who complied with the minimum requirements set in the first stage of evaluation will now be evaluated both on PRICE and HDI and /or RDP goals. Price will be **80** and **20** will be for **HDI** and / or other **RDP** goals.
