- The bid will be evaluated using 80/20 preference points system.
- Bid documents are available at **R500.00 non-refundable cash payment.**

- Bids must be enclosed in a sealed envelope clearly stating the tender number.
- All prices quoted must be VAT inclusive, except in the case of non-VAT vendors.
- No bid document will be accepted if not properly sealed and marked.
- The general conditions of contract will be applicable to this tender.
- Bids not signed by the bidders will be rejected.
- A valid original tax clearance certificate and proof of municipal rates and taxes must be attached.
- No rectification/correction fluid may be used on the document.
- Bids received after closing **TIME** and/ or **DATE** will **NOT** be considered.
