A minimum threshold of 40% must at least be achieved by service providers for them to proceed to the second stage of evaluation which is Price and B-BBEE.

2. PRICE AND B-BBEE

All the service providers/suppliers will be evaluated both on **PRICE** and **B-BBEE**. Price will be **80** and **20** will be for B-BBEE.
