SPECIAL CONDITIONS

- 80/20 preference point system will be applicable with 80 points allocated to price and 20 points towards the BBBEE status level of contribution.
 - The guideline for locally produced goods or locally manufactured goods with a stipulated minimum threshold where applicable will be applied.
 - A valid SARS Tax Clearance Certificate and the tax compliance status pin to be submitted. It is the responsibility of the bidder to ensure that the company's tax status remains compliant at all times.
 - National Treasury Central Supplier Database Summary report must be submitted.
 - In order to claim preference points a valid original or certified BBBEE status level verification certificate or a sworn affidavit completed on the DTI format must be submitted to validate the claim
 - Each page of General Condition of a Contract "GCC" to be initialled by the service provider/supplier.
 - Municipality reserves the right to accept any tender and, or part thereof, and does not bind itself to accept the lowest price or any tender.
 - Bids not fully completed and signed by the bidders will be rejected.
 - The validity to period for the submission must be 90 days
 - The eligibility as detailed in the Conditions of Tender will be applicable.
 - Bids must be placed in the Xhariep District Municipality's tender box. No emailed or faxed tenders will be accepted.
- a. *Prior to entering the Municipality premises, the representative delivering the submission may be subjected to temperature scanning. The Municipality reserves the right to deny entry should the reading be deemed above normal.*
- b. *There will be NO signing off on the SCM records register during this period. This is to avoid physical contact.*
